## Cleansing Notice under Section 708A(5)(e) of the Corporations Act

As announced today, SenSen Networks Limited (ASX: SNS, "**SenSen**" or "**Company**") has acquired the business and business assets of Snap Network Surveillance Pty Ltd.

As consideration for the acquisition, SNS has issued a total of 9,881,423 ordinary shares in the issued capital of the Company to Snap Network Surveillance Pty Ltd (**Consideration Shares**).

SenSen has also issued 368,421 ordinary shares in the issued capital of the Company to advisors to SenSen.

50% of the Consideration Shares are escrowed for 6 months from the Completion Date and the remaining 50% of the Consideration Shares are escrowed for 12 months from the Completion Date.

For the purposes of section 708A(6) of the *Corporations Act 2001* (Cth) ("**Act**"), the Company hereby notifies the ASX that:

- (a) the Company issued the shares without disclosure to investors under Part 6D.2 of the Act;
- (b) this notice is given under section 708A(5)(e) of the Act;
- (c) as at the date of this notice, the Company has complied with:
  - i. the provisions of Chapter 2M of the Act as they apply to the Company;
  - ii. section 674 of the Act; and
- (d) as at the date of this notice, there is no other information that is excluded information of the type referred to in sections 708A(7) and 708A(8) of the Act which is required to be disclosed pursuant to section 708A(6)(e) of the Act.
